Report on the ALMA Helpdesk from the 3rd Integrated Test (IT3)

Summary

The helpdesk was opened for testing and operations starting at the beginning of IT3 on January 5th, 2011. The helpdesk was used only during Part 1 of this test, during the "Proposal Generation and Submission" portion that took place January 5th-28th. The helpdesk was officially closed for ticket submission by the IT3 participants after the first load test on January 31, 2011. This was done to enable the test results to be collated and implemented so that the helpdesk could be deployed by March 1st, 2011. All of the requisite changes, enhancements and upgrades to the helpdesk and helpdesk operations were discussed during weekly telecons of the ALMA SciOps Helpdesk Working Group. Decisions were made in these telecons whether to approve or not approve the suggested changes from the IT3 report.

Unlike the previous Integrated Tests, the helpdesk testers did not have specific tests to perform or a test matrix to fill out. Instead, the plan was for all testers to use the helpdesk during their proposal preparation and submission testing, much as they would as ALMA Early Science proposers; these testers are called "Users" in this document. As feedback, we requested that these testers fill out a form specifically tailored for users. All the results are posted in Appendix A at the end of this summary. Aside from this, individual tests of helpdesk operations were performed by select users from each ARC in the Proposal Submission Emergency test.

Some IT3 testers (generally those affiliated with an ARC or ARC node) were given the role of "User Support Specialists" (USS), and were responsible for answering the submitted tickets. These testers followed the guidelines for helpdesk operations laid out in the Helpdesk Staff Guide (v2.0, available at https://safe.nrao.edu/wiki/bin/view/ALMA/Helpdesk). This guide describes policies, procedures and workflow that are in place for the ALMA helpdesk. Testers with the USS role familiarized themselves with these policies and followed the expected workflow as they answered tickets, including requesting more information from submitters, transferring tickets they were unable to address, and, when appropriate, generating "Knowledgebase" (KB) articles for the benefit of other users. As feedback, we requested that these testers fill out a form specifically tailored for USS. All the results are posted in Appendix B at the end of this summary.

Finally, a third group of testers were given the role of "Triage" staff. These individuals monitored tickets as they were received at each ARC and followed the instructions for assigning, resolving, transferring, etc., the tickets, as described in the Helpdesk Staff Guide. We requested that these testers fill out a form specifically tailored for Triage. All the results are posted in Appendix C.

A table of all IT3 participants and the roles they assumed is provided in Appendix D. (Note this does not include the 6 accounts setup for internal testing purposes.)

During helpdesk operations, 97 tickets were submitted, 39% to NA, 9% to EA and 52% to EU. No tickets were lost and all were assigned and subsequently resolved and closed.

Overall, the IT3 helpdesk test was a successful confirmation of the procedures outlined in the staff guide distributed to all ARCs and the JAO.

In addition, there were changes to the overall look of the helpdesk and procedures for replying to tickets. A summary of these changes are listed below.

Tests and Changes for IT3

There was one notable exception in the procedures described in the Helpdesk Staff Guide. This concerned tickets reporting bugs or enhancement requests for software tools, such as the Observing Tool (OT), Splatalogue, the CASA Simdata task, or the Helpdesk system itself. Currently, the Staff Guide says that in these cases, USS's should open a ticket in the corresponding Defect Reporting system for each tool (e.g. JIRA). Instead, it was decided in the course of this test, that USS and Triage staff should route the tickets as follows:

- OT: transfer to EU ARC; Triage assigns to Andy Biggs
- o UP: transfer to EU ARC; Triage assigns to Stephane Leon
- o Simdata: transfer to NA ARC; Triage assigns to Remy Indebetouw
- o Splatalogue: transfer to NA ARC; Triage assigns to Robin Pulliam
- Helpdesk: transfer to NA ARC; Triage assigns to Anthony Remijan

That is, tickets were assigned to the subsystem scientist of each software subsystem. The result of this was that some ARCs had a specified lead for a software subsystem, e.g. OT or Splatalogue. Bugs, enhancement requests or system errors were forwarded to the lead who then determined if a JIRA should be submitted.

Result: This procedure worked well and will continue through normal helpdesk operations. In specific cases determined by the subsystem scientist of each software system, select USS may be given access to the appropriate bug reporting system.

The overall number of departments was decreased from IT2. In addition, "Tooltips" for each new department were added to describe its scope.

Result: All tickets were assigned to the appropriate department. None had to be "reassigned". Reassignments were only done if a ticket was transferred to another ARC.

KB articles were added by scientific staff based on submitted tickets. The procedure was that first all KB articles be vetted by select scientific staff from each ARC before being published.

Result: While there were still some inconsistencies in the way the USS submitted KB articles, i.e. some went to draft, others published straight away, the overall opinion was that those that did not set the article to draft first, did not follow the instructions in the staff guide properly. "Draft" is and will remain the default setting for the submission of KB articles when the helpdesk is open for full operations.

A "Proposal Submission Emergency" department was added 24 hours before the proposal deadline. Available to all ARCs, this department was manned for the full 24 hours through the proposal deadline.

Result: The JAO created a wiki page with a contact person who would be available in case of an emergency. In every case, (7 emergency tickets were submitted across 8

hours), Triage from each ARC was able to contact the JAO within minutes of receipt of the ticket. Contact with the JAO representative was through phone, email and forwarding the ticket through the helpdesk. A transcript sent from the JAO representatives who participated in the emergency testing procedure is below and comments from the authors of this document are added (in italics):

Comments and suggestions on JAO Emergency Call Test

Stephane Leon & Juan Cortés

We performed a JAO Emergency Call test with the Helpdesk and ARC people. The test showed us the following lessons that need to be implemented for the future JAO Emergency On-Call system. These lessons are the following:

- 1. Murphy's law works always! For example, a phone call can accidentally be missed by pressing the wrong button on the phone (not a joke).
- 2. We will have a list of persons with a shift of 6~8 H in stand-by. Will the people at the OSF participate to these turnos? (Currently: TBD) We will need a minimum of 4 people for 36 hours.
- 3. We will need a list of phone number here at the SCO to call to the right person in case of problem (CIPT, archive, web server). It would be even better to have a troubleshooting list (server down, archive not working, power cut, etc...) with the persons to contact.
- 4. If we are going to use cellular phone, we need to have one from ALMA. We won't call back to a foreign country with our cell phone. (Currently: Pending)
- 5. We may need to explain, even quickly, to the astronomers at the DSO what the purpose of such task is and how we are supposed to act.
- 6. We could have a backup number to the Emergency Call, i.e. a backup person in case the other does not answer. It would mean that 8+ persons would be necessary to cover 36 hours. But I guess we could use the people at the OSF as well. (Currently: TBD)
- 7. We found that for this test the notification from the ARC messages fail sometimes. We will need to test the system first between ARCs and JAO. (Currently: It was determined that messages forwarded from the Kayako system were being flagged as SPAM when received in Chile. This issue has since been resolved.)
- 8. It is not clear the way for contacting the ARCs from JAO. We need a contact person at the ARCs in order to notify the status of the problem. Thus, we need an expedite channel of notification when a problem is detected at JAO (Currently: TBD)
- 9. We need a clear internal (Science (PHT) > IPT >IT > Archive) procedure in case of emergency. (Currently: TBD)
- 10. I case of catastrophic failures (e.g. Archive down) we need contact person or email list at each ARC in order to notify the problem and avoid unnecessary calls to JAO. (Currently: TBD)

Summary of Feedback - USERS

From the questionnaire form (see Appendix A):

Question 1. All 71 users were able to log in effectively. There were no issues

 Question 2. In general the departments were descriptive enough for people to submit their tickets but the descriptions in the inline text and tool tips used too many abbreviations and acronyms.

PROPOSED CHANGE: Eliminate the abbreviations and jargon in the tooltips. *(Approved)*

The text of the tool tips was also too short.

PROPOSED CHANGE: Expand the description of each department. *(Approved)* Finally, every department needs to have a mouse-over tool tip. *(Approved)*

Questions 3. The knowledgebase worked as advertised but many people did not find an
answer to their questions because the KB lacked the requisite information. As a result, a
couple of people reported not being able to see the suggestions as they typed their
questions.

PROPOSED CHANGE: KB searches crawl the body of the article and not the title so it is imperative that the body of the KB article includes all the words that are in the title as well. *(Approved)*

If we are going to use the "stars" reporting system, they should also note how many votes were cast. (**Not Approved**)

It was also suggested that the KB articles were geared more towards testers than actual observers and this may be a problem going forward.

PROPOSED CHANGE: All KB articles will be vetted by the scientific staff before going live on March 31. This will ensure their usability in full helpdesk operations. *(Approved)*

Questions 4-6. 33 users submitted a total of 97 tickets. Only 1 user reported not getting
any notification that their ticket was submitted and subsequently assigned and resolved.
Everyone else got notification that their ticket was submitted successfully and was able
to follow the link provided to view their ticket upon login.

PROPOSED CHANGE: It was also suggested to use English only in the notification. *(Approved)*

• Question 7. The replies were almost 50/50. Most users replied they did not get a notification to change their ticket status from resolved to closed. However, we believe that this was because the line of text in the email was not prominent enough.

PROPOSED CHANGE: We will make the "close the ticket if you believe the issue has been resolved" text in the reply of the ticket more prominent. (Approved)

- Question 8. Some suggestions/comments/questions included:
 - a. Changing the names of the ticket IDs from random to incremental. (Approved)
 - b. Change the name from tickets to queries. (Not Approved)
 - c. Make sure the ticket link is in each response to that ticket. (Approved)
 - **d.** Allow closed tickets to be seen by the user. (*misinformed; users can already see all their tickets regardless of status*)
 - e. Make sure cookies are enabled in the browser. (reported in published KB article #41 in current helpdesk)
 - f. If you attach a file to a ticket, you do not get notified if it attached successfully. (File size is a problem, as well as notification; actively being worked on.)

Summary of Feedback - USS

From the questionnaire form (see Appendix B):

- Question 1. All 40 USSs were able to log in effectively. There were no issues.
- Question 2. In general, the departments were adequate but in the view, they are too

long to be seen and the categories below cannot be selected. One USS attached a file that was not viewable by the user.

- Question 3. No problems.
- Question 4. If there were problems in the workflow, it was because the USS did not read
 the staff guide. This was the impression from the triage staff and was noted by several
 USSs as well.
 - PROPOSED CHANGE: Additional USS training is necessary at each ARC before going live on March 31. (Approved)
- Question 5. 8 of 40 USSs submitted KB articles; all 8 said the guide was clear. 14 KB articles were produced. Only one USS commented on the instructions being not clear and only one USS commented that they did not know to submit the article as "draft" but also admitted to not reading the staff guide.
 - PROPOSED CHANGE: Additional USS training is necessary at each ARC before going live on March 31. (Approved)
- Question 6. Some suggestions/comments/questions included:
 - USSs have too many permission, like being able to reassign tickets.
 - PROPOSED CHANGE: Edit Kayako permissions for USS.
 - The USS's permissions cannot be changed in Kayako without major reprogramming of the software. (Not Approved) It is essential that the USS follow the guidelines of the workflow.
 - o There was no message that a file was attached to a ticket.
 - PROPOSED CHANGE: Attachment is visible through the Kayako Web view, but not through email alerts. Is it possible to edit the email alert to note that a file is attached? (ACTION PENDING)
 - o Add a pop-up to the tab headings for "Post Reply", "forward", etc...that describe their scope.
 - Requires significant changes to Kayako; not being pursued. (Not Approved)
 - The "view all" ticket option did not work, as reported by select USSs.
 - This was because the USS changed the view in a department. ACTION: This clarification has now been added to the staff guide.

Summary of Feedback – TRIAGE

From the questionnaire form (see Appendix C):

- Questions 1-3. All 8 triage staff were able to log in effectively. There were no issues
- Questions 4-6. Some of the workflow needs to be refined as to what happens to a ticket
 that has already been assigned to a USS but the user is sending a comment back to
 Triage and what prevents a USS from posting a reply to a ticket not assigned to them.
 These are procedural and not something that has to be implemented in the Kayako
 system.

PROPOSED CHANGE: Additional USS training is necessary at each ARC before going live on March 31. *(Approved)*

• There were also no real problems transferring tickets between ARCs from Triage. There were some issues regarding the transfer of a Japanese ticket.

PROPOSED CHANGE: Edit the staff guide with clearer instructions on the action needed with the transfer of a Japanese language ticket. *(Approved)*

Summary of Actions to be taken for Final Deployment:

A link off the science portal webpage will be added that will take you to the KB articles of the helpdesk where it is not necessary that you first login. This is so the general public can look at the KB articles without actually registering.

How does the PHT correspond with the ARCs? Workflow will be decided at a face-to-face meeting in April, 2011.

What happens if the UP goes down? What is the contingency and how is it reported by the users?

In this case, the other science portals at the ARCs will activate and the helpdesk will be available outside of the ALMA science portal through the ARCs.

How do users learn to use the helpdesk?

Descriptions of helpdesk operations are included in the "Guides to the ARCs," available under "Documents & Tools" in the science portal.

The notification was written in Japanese. This would be because I selected my local ARC as EA, but astronomers in Taiwan are also supposed to submit ticket to EA ARC. Therefore it would be good to use English in the automatic notification.

Yes.

No, I got no notification from the helpdesk. My question was about one option of the target list in

OT, and the answer was "that option is not available yet". So I understood the situation and CLOSED my ticket 10days after the submission. Did I have to wait the notification to change the status?

- I was able to login.

In 'Data Reduction' I would add in the explanation 'CASA' (I cannot see any explanation for this department and for the 'Archive and Data Retrieval', though the latter does not need extra info in my opinion).

Knowledgebase: The Knowledgebase can be accessed via a hyperlink that can be found in the middle of the login page. If there are existing KB articles relevant to your to question, were they suggested as you typed in your ticket description? Any other comments? There were KB articles relevant to the question, but they were not suggested while I typed my ticket (they were found though when searched into the KB with the 'search' tool).

I found confusing when I click in KB I see 'ALMA' and below one article followed by 'More topics' and below that another 3 articles that do not seem to have a category (is that left-overs from previous tests?).

After submission, did you get a notification with a ticket ID assigned? Were you able to access your ticket from the link provided in the notification? Yes

Were you given notification within 48 hours after submission that your ticket was resolved or that it was being actively worked on? Yes

Interaction with helpdesk staff: did this proceed as expected? Yes

Were you given notification that your ticket was resolved and that you needed to change the ticket status to "CLOSED" if the reply resolved the issue? Yes

Any other problems/comments/questions/suggestions?

- 1. I was able to login to the HelpDesk with no problems.
- 2. a) *Every* category should have mouse-over text; e.g., Data reduction mouseover should specify CASA. There should not be acronyms used in the mouse-over text: what the heck is PHT? Also, "PhI" and "PhII" look weird. Who's "Phil"? Just use the extra "ase" for crying out loud!
 - b) As long as I don't need to know what PHT is, I think I can figure out where to submit.
 - c) What are the tooltips? Are you referring to the mouse-over text? If so, see 2a.
- 3. None of my tickets had relevant answers in the knowledgebase, although I feel like I should have started writing a ticket about Stephanie Meyer just to make sure. If you're going to allow "helpful

/ not helpful" voting to determine the stars, the Knowledgebase should say how many votes there were.

- 4. Yes, the notification & link were great.
- 5. I received quick notification (< hours?) for each of my tickets.
- 6. One staff member kept coming to my office and telling me that I should or shouldn't submit tickets, according to his mood at the time and how much he wanted me to annoy the person currently on Triage. Will that be standard operating procedure?
- 7. I received notice in each case, except for the last couple of tickets by Harvey, but the status was changed after the test was done so that probably doesn't count.
- 8. The ticket identifications are dumb. At the very least, the first three letters, instead of being assigned "randomly" (if they are) could identify to which department a ticket had been submitted! Also, is there a limit of three attachments per reply post? I'm not sure that's wise.

1. Were you able to login to the helpdesk as a USER after authentication? If not, what happened, who did you contact and what was the solution?

Ans: Yes, no problem

- 2. Without submitting a ticket, "mouse" over the new helpdesk departments and comment on the following:
- a. Are the new departments descriptive in their scope and functionality?
- b. Are you able to find the right department to submit your question?
- c. Do the tooltips provide enough information as to where to submit your ticket? Ans: a. Yes, looks fine.
 - b. Yes, it works properly
 - c. Yes, while I suggest to avoid using abbreviations such as PHT, SB, PhI, PhII in the tooltips.
- 3. Knowledgebase: The Knowledgebase can be accessed via a hyperlink that can be found in the middle of the login page. If there are existing KB articles relevant to your to question, were they suggested as you typed in your ticket description? Any other comments?

 Ans: It is good to provide such knowledgeable. While the current categories appear to be designed for testers rather than observers.
- 4. After submission, did you get a notification with a ticket ID assigned? Were you able to access your ticket from the link provided in the notification?

Ans: Yes, I did get the notification, and can assess my ticket from the provided link. Actually, in

total I got three mails (w. different ticket IDs) for a single submitted ticket. Also the email was in Japanese......

5. Were you given notification within 48 hours after submission that your ticket was resolved or that it was being actively worked on?

Ans: Yes, I received the response within a few hours.

- 6. Interaction with helpdesk staff: did this proceed as expected? Ans: Yes, it is fine.
- 7. Were you given notification that your ticket was resolved and that you needed to change the ticket status to "CLOSED" if the reply resolved the issue?

Ans: No, not received any notification to change the ticket status

8. Any other problems/comments/questions/suggestions?

1. Were you able to login to the helpdesk as a USER after authentication? If not, what happened, who did you contact and what was the solution?

yes, I have never encountered problems to login

- 2. Without submitting a ticket, "mouse" over the new helpdesk departments and comment on the following:
- a. Are the new departments descriptive in their scope and functionality? yes.
- b. Are you able to find the right department to submit your question?
 yes. I find a bit confusing that the departments are called "categories" in the "submit a ticket" page
- c. Do the tooltips provide enough information as to where to submit your ticket? yes.
- 3. Knowledgebase: The Knowledgebase can be accessed via a hyperlink that can be found in the middle of the login page. If there are existing KB articles relevant to your to question, were they suggested as you typed in your ticket description? Any other comments?

No, I have not found any related article...

4. After submission, did you get a notification with a ticket ID assigned? Were you able to access your ticket from the link provided in the notification?

yes, I got ID YWU-931637. And yes, I could access it from the link provided

5. Were you given notification within 48 hours after submission that your ticket was resolved or that it was being actively worked on?

yes, I got it resolved after just 20 hours

- 6. Interaction with helpdesk staff: did this proceed as expected? yes.
- 7. Were you given notification that your ticket was resolved and that you needed to change the ticket status to "CLOSED" if the reply resolved the issue?

No, I just received an e-mail with the answer. Then, I logged into my account and the ticket was

already marked as 'resolved', but I got no notification that I needed to close it.

Were you able to login to the helpdesk as a USER after authentication? If not, what happened, who did you contact and what was the solution?

YES but it would be so nice to have single-sign on for all ALMA services!

2. Without submitting a ticket, "mouse" over the new helpdesk departments and comment on the following:

(after clicking on 'submit a ticket', though!)

a. Are the new departments descriptive in their scope and functionality?

Tooltip acronyms are rather opaque, to be honest I would rather have 2-3 lines of text which I can

read all the time than something ephemeral containing acronyms I do not understand (PHT etc.). In

genral, vital information should be available in more permanent form than tooltips, which should be

an extra reminder, not the only information.

b. Are you able to find the right department to submit your question? Some confusion as below

c. Do the tooltips provide enough information as to where to submit your ticket? Not really, firstly

because of the confusion with acronyms and the ephemeral nature of tooltips and secondly, supposing I have a problem with proposal submission in the OT, does this come under General Queries, (if I can figure out that PhI manager might include that) or does it come under Observing

Tool, or does it come under Proposal Submission Emergency?

If this happens to other users, they will likely attempt to reply to whoever sent them the ticket rather than updating the discussion through the helpdesk. The address, of course, is 'do-not-reply@almascience.org', but if users delete the initial helpdesk emails they could be frustrated in their attempts to respond. I would simply recommend making sure the ticket link is in every email response.

Showing the most popular articles on the main knowledgebase page is a good idea though. Searching the knowledgebase worked well for me and gave relevant ticket results.
- 4. After submission, did you get a notification with a ticket ID assigned? Were you able to access your ticket from the link provided in the notification?
- Yes, this worked fine. However, for the notification mail I would suggest that the sender be identified as 'ALMA Department' or similar, not just the department. Users might get confused as to who the ticket is from otherwise...
- 5. Were you given notification within 48 hours after submission that your ticket was resolved or that it was being actively worked on?

Yes, I always got a relatively fast reply.

6. Interaction with helpdesk staff: did this proceed as expected?

Yes, my tickets were assigned to people that replied quickly and often quite wittily! The one thing that confused me was the status of the ticket and when/whether I was supposed to change it e.g. from 'Pending' to 'Open'. As a user, I know that I should close tickets if the matter is resolved, but beyond that I wasn't sure whether to touch the status. Also, I am never sure whether to first reply and then change the status or the other way around. For example, I would sometimes like to close the ticket but send a thank-you to my support astronomer – I suppose I first reply, then close the ticket? This should be made clear in the instructions for users. Is there a manual just for users?

- 7. Were you given notification that your ticket was resolved and that you needed to change the ticket status to "CLOSED" if the reply resolved the issue?
- I always got a notification (I think!) when somebody replied to my ticket. The status was not always 'resolved' when it should have been, and I was not normally asked to close the ticket (once or twice maybe).
- 8. Any other problems/comments/questions/suggestions?

One thing I found annoying was that when replying to a ticket I could never see the entire ticket conversation (or at least the last entry by User Support that I should be replying to). This makes answering several detailed questions difficult and you tend to forget to mention some aspects that were asked.

For one f2f visit request I asked for financial support, but was able to submit the ticket without a justification for this. The justification should be mandatory.

As a test, I tried to submit a ticket with a large fits file attachment (17MB). This did not work, and instead of getting an error message I was taken back to the main Helpdesk screen. The ticket was not submitted. I think that the size limit for attachments should be indicated somewhere and then an error message should be given if the attachment is too large.

I had one strange issue that as a user I could see a ticket submitted by Paola (as staff, and for some reason cc'd to my e-mail address). The ticket in question is GUJ-188071. Surely, a user should not be allowed to view anybody else's tickets?

The workflow failed mainly in the status updates: ome tickets were never changed to resolved although the ticket was resolved. Did you return any tickets to Triage (Section 7)? If so, did you include a note as to why (Section 6.3)? Yes.

The e-mail was correctly forwarded. The default alerts did not notify me when I was assigned a ticket, but that may have been due to my triage role. I changed this alert manually, and then I got all the alerts I wanted.

The one thing that staff users were not clear about in the workflow was which status to change the ticket to after replying. Some forgot, some changed it wrongly.

No, I did not return any tickets to triage but asked several other staff to do so. This appeared to work fine, although the ticket was never reset to 'unassigned' as it should have been.

c. Did you need to forward a ticket to someone not in the helpdesk system (Sections 6.4)? If so, did it work as expected?

I tried forwarding a ticket to Stephane Leon about a submission emergency and he said he never received the mail. Testing the forwarding on myself I found that an e-mail alert was sent, but I could only see the very last reply (i.e. 'I forward you this ticket') but not actually the submitted text. The only way for an external user to see the ticket content is if the USS forwarding the ticket thinks to include the actual request in his 'Forward' reply. This is fine, but it has to be made absolutely clear, if possible by a note/text that appears when you forward a ticket.

5. If appropriate to the question, submit a Knowledgebase article as a DRAFT as described in Section 6.5 and Section 8 of the Helpdesk Staff Guide. Were the instructions clear? It was not clear to all users that they should submit the knowledgebase article as 'Draft' – some directly published it! I suggest allowing 'Staff' roles only permission to compose draft articles, not to publish them (see my rambling about a greater difference between triage and staff accounts below). I had to tell several staff users how to publish a knowledgebase article, so apparently it was not completely clear to everybody.

I think that the Staff helpdesk needs many more 'hint' or 'tooltip' messages that either pop up when needed or are visible prominently. Many staff will not use the Helpdesk regularly enough to think of everything automatically, so they should be helped.

6. Any other problems/comments/questions/suggestions?
I found that searching tickets by 'Last replier' and 'Observer name' did not work at all. On the other hand, searching by ticket ID or subject worked very well.

If as a staff I want to open a ticket the procedure is not very straightforward.

If I go on 'New Ticket' -> Email I see a number of departments, many of which I cannot submit tickets to (NA and EA departments). The problem is that I can't read the full department name

and therefore have to work out by trial and error which departments I can submit tickets to. I think I should only be able to see departments I can submit tickets to. One other thing is that I get asked for a 'User e-mail'. Upon investigation, it turns out that this is where notifications are sent, so surely it should be the Staff's normal e-mail? In that case, it should be automatically filled (or set as default).

Regarding the emergency department test:

We got several tickets in the Europe on-call time. I first forwarded the tickets to Stephane Leon, who told me afterwards that he never received my tickets forwarded. Since I did not get any reply to the tickets, I called to the number given in the wiki. The first time I had to call 3 times within half an hour before I got a reply (something was apparently wrong with the settings of Stephane's mobile). The second time he got the phone the first time.

As a triage person, I realised that most of the USS did not change the status of the tickets once they had been resolved. We will have to clarify the workflow to them.

Regarding the views, the triage view should contain only 'unassigned tickets' and 'tickets returned to triage'. This cannot be configured right now. In fact, choosing the view 'Unassigned' shows a lot of tickets that have been assigned and closed.

Every person (at least all the triage persons) should be able to view the tickets from other Executives (only-read permission). This is very useful to build the knowledge database. There may be tickets that require the same answer in all Executives. If the search tools work properly, then sharing the knowledge should work very efficiently.

It is not clear to me how the time works for 'Response overdue'. There was a ticket that was open but it never got overdue. Does a ticket get only overdue if nobody ever replied to it?

And one more question, what does the colour code mean? Some tickets are blue and others yellow, and some have a red arrow. What is the meaning of these colours/symbols?

I found it strange, when trying to review all tickets, that I had to click "View All" on the left panel and then change my "view" again in the right panel to something like "triage view". Of course, once you know the routine this isn't a problem.

- 1) Yes
- 2) Yes
- 3) Yes, the defaults were perfect
- 4) -----
- a. Yes, this was easy to do
- b. I don't remember any tickets being returned to triage on my watch
- c. Yes, I transferred OT tickets to the EU arc, with a note from me in my triage role
- 5) I did not try this
- 6) This was also surprisingly easy to use. I am pleased.

Were you able to login to the helpdesk via your TRIAGE account set up by the helpdesk administrator (Section 1.1 and 5.1)? If not, what happened, who did you contact and what was the solution?

Yes, no problems.

2. Are the entry forms adequate and capture enough information so that you could answer the ticket? If not, which departments/forms need improvement?

Yes, I could answer the ticket or know who to assign it to from the information provided.

3. Did the default alerts work which notified you of a submitted ticket (Section 5.3)? If not, was it clear how to change the notifications (Section 5.3)?

I was notified of a new ticket or one that had come to EU from another ARC, and whenever a response was overdue. However, I had to customise the alerts myself to see e.g. if a ticket was assigned to me, or notes that had been added. But this was not a problem and worked well.

- 4. Follow the "Procedure for responding to Tickets Triage" in Section 6 of the Helpdesk Staff Guide (which is also summarized in Section 6.6) in answering/assigning the submitted ticket.
 - a. Did the workflow in Section 6 work as expected in either assigning or answering a ticket? If not, what was not clear?

This worked well, no problems.

b. Were any tickets returned to Triage from a USS (Section 7)? If so, did the tickets include a note from the USS (Section 6.3)?

Yes, I had at least one ticket returned to triage (upon request). However, the ticket was not set to unassigned, and no note was included.

c. Did you need to transfer (or did you receive) a ticket to another ARC (Sections 6.6 and 3)? If so, did the tickets include a note from the USS (Section 6.3)?

I received several tickets from other ARCs, all with appropriate notes. I also transferred tickets to other ARCs with no problem.

5. KNOWLEDGEBASE ARTICLES (Section 6.5 & 8): Periodically, you should check to see if there are any draft Knowledgebase articles awaiting review. Edit the KB article accordingly (if needed) and then change the status of the article from DRAFT to PUBLISHED. Did the articles appear in knowledgebase? **NOTE: For IT3, only Triage should PUBLISH KB articles.**

I know that this is difficult under the current Kayako system, but I find the current way of dealing with Knowledgebase articles confusing for triage people/those in charge of publishing. There must be some way to visually highlight 'draft' articles that have to be edited and published, and also make a triage person aware of any newly published (perhaps by another ARC) articles (perhaps by leaving them in bold until read or something). Can we see draft articles from other ARCs?

I think that we should only be able to see draft articles from our own ARC, and then whoever is on triage is responsible for editing and publishing them. But there also needs to be a way for triage people to be constantly aware of what is new in the knowledgebase. We should discuss this at some point.

6. Any other problems/comments/questions/suggestions?

I think in general there has to be more of a distinction between 'staff' and 'triage' roles. If staff should not do something (e.g. assign tickets to somebody else, change departments except for 'return to triage', publish knowledgebase articles, answer tickets not assigned to them) then they should not be given the rights to do so, as this just causes confusion and leads to mistakes.

There were some issues with the Emergency Department (a ticket I submitted to EA during their triage took 3 hours before Chile was successfully contacted, we failed to contact Stephane on his mobile for half an hour) that should be discussed.

I still find the ticket 'views' confusing and think that the triage view is poorly configured. It should show unassigned tickets as well as those returned to triage and those that are

transferred from other ARCS, but not those assigned to me as a user – I could not find a way to configure this.

I also don't like the fact that if I look at a ticket in a given department my view then shows me only that department — I think I should always see all departments, unless I specifically select only one specific department.
